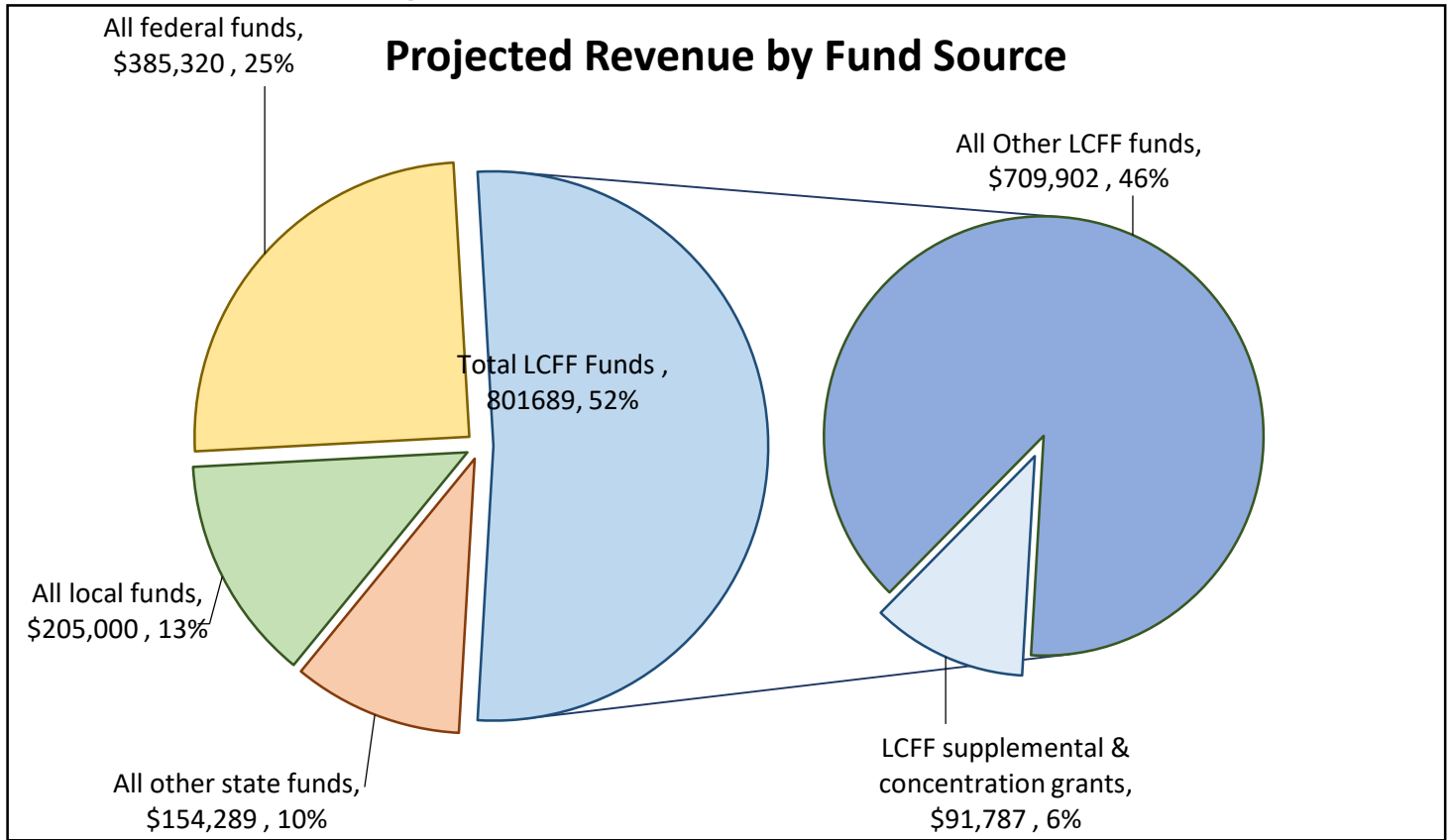

## Budget Overview for the 2024-25 School Year

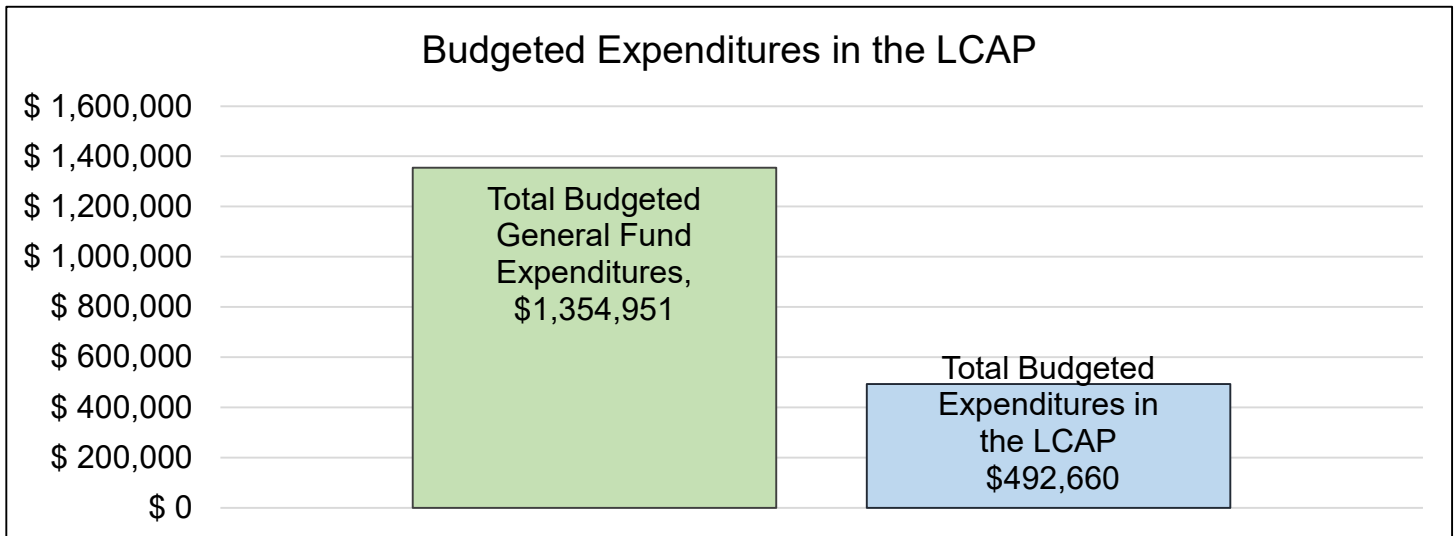


This chart shows the total general purpose revenue Shade Canyon School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Shade Canyon School is \$1,546,298.00, of which \$801,689.00 is Local Control Funding Formula (LCFF), \$154,289.00 is other state funds, \$205,000.00 is local funds, and \$385,320.00 is federal funds. Of the \$801,689.00 in LCFF Funds, \$91,787.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

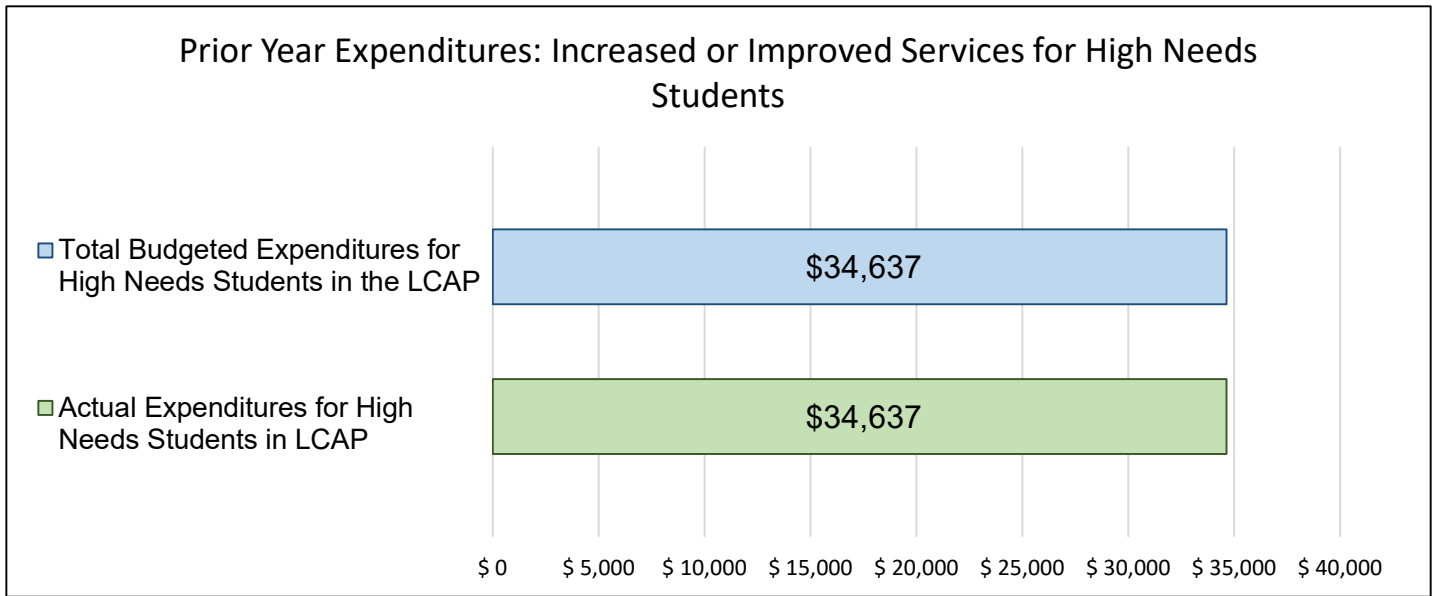

## Plan Summary [2024-2025]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Shade Canyon School (“SCS” or “Shade Canyon”) is a new independent charter school serving elementary-aged children in Lake County, California. The school opened in September 2023 on a leased site, currently under development, in beautiful Kelseyville, California, serving grades TK-2. We will add one grade per year up to Grade 8. Our expected enrollment for the 2024-25 school year is 75 students in grades TK through third.

**SCHOOL ORGANIZATION:** At the heart of Shade Canyon School are the parents and children who make up the Charter School community. The Board of Directors, the Administrator, the administrative staff and the faculty provide ongoing administration, management, and pedagogical orientation. The administrative staff supports the teaching faculty in their most important work of educating our children. Shade Canyon employed one administrator, one office manager, two teachers, two classroom aides, and four part-time teachers of specialty subjects for the 2023-24 school year. We released the administrator from duty in March 2024. In 2024-25, the school will employ a new administrator, a classified staff member, and one or two teachers (depending on enrollment), to join the original team.

**STUDENT BODY:** As of June 1, 2024, Shade Canyon’s enrollment stood at 38 students. 5.3% identified as American Indian or Alaska Native, 13.2% as Hispanic or Latino, 76.3% as White, and 5.3% as Two or More Races. 47.4% are eligible for free/reduced lunch. 4 students had IEPs. No English Learners (EL) were enrolled.

**CURRICULUM:** Shade Canyon is inspired by the core principles of Public Waldorf education as we teach the California state standards. The course of study is interdisciplinary: we value the arts, languages, and other subjects that are often considered “electives.” They are essential elements of a holistic education that includes the core standards of math, language arts, science, history, and social studies. The curriculum is experiential and tailored to meet the child at their stage of development so all learners can grow to their potential.

Shade Canyon’s vision is: “We believe that by honoring simplicity, we nurture the spark of the individual and nourish a thriving community.” The mission is to “cultivate inspired learners.”

- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

## ***Contributing Actions Annual Update Table***

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
